**JAI MEDICAL SYSTEMS EARNS HIGHEST QUALITY RATING IN MARYLAND

BALTIMORE -- The Maryland Department of Health and Mental Hygiene has announced that Jai Medical Systems has earned the distinction of being ranked as the highest quality Medicaid Managed Care Organization (MCO) in the State of Maryland for the sixth year in a row.

On an annual basis, the Department of Health and Mental Hygiene evaluates MCO quality. For CY 2010, **Jai Medical Systems became the first MCO in the history of the Maryland Medicaid program to achieve a perfect score by exceeding the incentive targets in all 10 Value Based Purchasing Initiative measures. Jai Medical Systems repeated this feat achieving 10 out of 10 Incentives in the Value Based Purchasing Initiative measures for CY 2012.** Jai Medical Systems' performance distinguishes the company not only in Maryland, but ranks the company among the best in the nation. In fact, Jai Medical Systems scored above the 90th percentile for all the evaluated measures ranking the company in the top 10 percent of Medicaid plans in the nation. All results are reviewed and audited by an independent agency.

In an effort to ensure and assess the quality of health care delivered to Marylanders in the Medicaid program, the State of Maryland evaluates MCO performance based on its Value Based Purchasing Initiative (VBPI). The VBPI rates each MCO on 10 specific health care performance measures. Examples of some of the performance measures include: the percentage of children receiving all of their required immunizations, cervical cancer screening rates, and the percentage of diabetics receiving an annual eye exam. Currently, there are seven MCOs participating in the Medicaid program serving over 950,000 Marylanders.

The State of Maryland also evaluates the quality of care delivered to Marylanders using a great variety of performance measures and summarizes their findings in a Report Card that is distributed to all new enrollees. This Report Card evaluates 6 overarching areas of care: Access to Care, Doctor Communication and Service, Care for Kids, Children with Chronic Conditions, Taking Care of Women, and Care for Adults with Chronic Illness. The newest Report Card released by the Department of Health and Mental Hygiene for 2014, shows Jai Medical Systems as the only MCO to receive three stars in every measured category. A rating of three stars is the highest rating possible.

Jai Medical Systems is a minority business based in Baltimore City serving approximately 25,000 members.
